



2022 Gerald J. Ring High School Scholarship Application

This scholarship application is for current high school students who are graduating in June and planning to attend a higher education institution starting the Fall.

Scholarship Amount

Members First Credit Union (MFCU) will be awarding one \$1500 scholarship to a high school senior. The scholarship may not exceed the total cost of tuition as billed by the school. The scholarship funds will be sent directly to the school.

Eligibility Requirements

- You have been a primary member for 3 months
- There is activity on your account within the 3 months
- You are a high school senior
- Your total cumulative GPA is a 3.0 or higher
- You are enrolled for at least 9 credits for the Fall semester

**MFCU employees, committee members, other volunteers and their families are not eligible. Previous scholarship winners are not eligible.*

Selection Criteria

Applicants will be evaluated based on the following five categories.

- Community service & volunteer work
- Employment experience
- Extra-curricular activities
- Essay
- GPA

Deadline

The completed application, essay, and transcript must be submitted by Friday, July 15th, 2022.

Applicant Must Submit

1. An official high school transcript reflecting the most recently completed semester. This must be received by the close of business day Friday, July 15th, 2022.
2. An original of each of the following:
 - a. Completed and signed Members First Credit Union Scholarship Application
 - b. Typed, double-spaced essay 500 words or less on the following topic:
 - i. How do you plan to use your studies to achieve your future career plans?

Awarding of Scholarships

Decisions will be made by the MFCU scholarship committee. All scholarship decisions will be made by July 29th, 2022, and all decisions are final. All applicants will be notified by mail.
